NOTICE TO MEMBERS OF QBEB

THE NEW "GOLD EXECUTIVE PROGRAM" UNDER THE GOLD BULLION ACADEMY OF QBEB CENTRE OF EXCELLENCE (QCOE) FOR ALL NEWLY REGISTERED CONSULTANTS

QBEB is continuously upgrading and improving the development needs of the members. As such, QBEB would like to introduce the "New Consultant's Training Programme" for its members who wish to upgrade to consultant. The training modules and delivery method were designed by the **QBEB Centre of Excellence (QCOE)**.

With effective from **22 October 2022**, QBEB is pleased to announce that we will launch the "**Gold Executive Program**" (GEP), brought to you by the Gold Bullion Academy (Division) under the QCOE. The training programme offers an executive module for members who are looking to build their career and/or improve their skills with Quantum Metal as a Consultant. The training programme consists of a mandatory elementary and an intermediate module, as below:

1) ELEMENTARY MODULE:

This module is to allow all members to study the basic knowledge by visiting QMSB (www.quantummetal.com.my) and QBEB (www.qbeb.org) website:

- i. The Company and its business
- ii. Basic Product Knowledge.
- iii. Resource and Contact.

Consist of 20 assessment questions.

- a. The test can be completed any time before the Intermediate Module Training start. You can also do it on the same day of the Intermediate Module Training.
- b. If your score is less than 50%, you must retake the exam within two weeks. However, the member can still proceed to the training of Intermediate Module during the training session.

2) INTERMEDIATE MODULE:

This module will be conducted by trainers to go through all the necessary knowledge as a consultant for other members:

- i. Governance, Shariah and Compliance.
- ii. Code of Conduct and Business Ethics.
- iii. Gold, Money and Economy.
- iv. Company and Product Knowledge.

Consist of 80 assessment questions.

- a) If you score less than 70%, you must retake the exam within two months (2 free attempts; if you fail, you need to pay **RM100.00 (Malaysia Ringgit One Hundred)** for the next two attempts).

- b) Certificates (both, digital and hard copy) will be provided to each member who has passed the assessment.

The course will be available in three (3) different languages of **Bahasa Malaysia, English, or Mandarin**. Members are required to notify Membership Care via email at care@qbeb.org within 1 – 3 working days in advance after have made successful payment to QBEB GSA. The URL link for the training and the assessment will be sent to your personal email after registration.

All members are encouraged to start their career with adequate knowledge and skill to embark on a rewarding journey as a competent registered consultant, a Quintessential Members of QBEB and be guided by the above as we move forward with the new requirements during the improvisation phases.

The course is not limited to new Consultant, we encourage even the existing Consultants to take up the training / test for continuous enhancement of skill and knowledge. The first 2 attempts (training and tests) are free!
