ALL CONSULTANTS WHO HAVE ATTENDED QMCU TRAINING MUST COMPLETE A MANDATORY ASSESSMENT UNDER THE GOLD EXECUTIVE PROGRAM (GEP).

QBEB would like to inform all consultants who have previously attended QMCU training that they are required to take the mandatory assessment under the Gold Executive Program before 30th November 2022.

The assessment consists of two categories, which are **Elementary** and **Intermediate** questions. Both must be taken and completed by all consultants. The consultants will receive an email together with the access code for the assessment. QBEB will share the results with the consultants. If the consultant fails, they must attend the training conducted by QBEB trainer within a month.

The passing marks for Elementary and Intermediate are 50% and 70% respectively. The potential consultants or candidate will be given two attempts to answer the assessment test question after the trainings are conducted within specify period, 3 to 5 days. If the consultant failed both attempts at the assessment of the GEP stage, they have to pay RM100.00 for every two attempts until they passed.

1. **Gold Beginner Program (Elementary)** requires a **50% passing marks**. No additional fees are required. Candidates need to familiarise themselves with the resource web page of QM and QBEB. A candidate must pass this elementary test before proceeding to Gold Executive Program (GEP) training and assessment.
2. **Gold Executive Program (Intermediate)** requires a **70% passing marks**. Training and lesson will be provided prior to the test. Within 3 days after the training, an online assessment must be taken. Candidates are given 2 attempts to pass. After the 2nd attempt, the next training and lesson plus 2 more attempt of the test, a fee of RM100.00 will be imposed.

Upon successful completion of the GBP and GEP assessments, the candidate will be given a certificate and deemed qualified to undertake sales of QM products.

Please be informed that the passing of GEP under the Gold Bullion Academy will be displayed on the Consultant Directory where it will help to profile the consultant's competency.

Please take serious note to take and complete the above-mentioned assessments as soon as possible, as we will impose disciplinary action on those who refuse to take the assessments, including withholding commission payment, and will only be released once they have passed them.
